

## **“Rules of conduct”**

**The summer season runs from 25/04 to 30/09 of each year.**

Seasonal tents are assigned from the last Saturday of May to the second Sunday of September, during this period the Bathing Establishment opens at 8.00 and closes at 20.00. Towel service and access to the supervised pool will be guaranteed.

The opening hours and the swimming pool regulations are posted at the entrance to the pool.

In order to guarantee your position on the beach, please confirm your seasonal and monthly pass by February with a deposit of 30%, and pay the seasonal balance by August of the current season.

Except for monthly and seasonal bookings, the balance of your stay is always required upon arrival at the beach.

Bookings of tents are nominative, therefore it is not allowed to sell or sublet the rented equipment.

Each tent can accommodate a maximum of 5 people (including children). For seasonal and monthly tents, the maximum number is 7 people. It is therefore recommended not to exceed this presence to avoid unpleasant crowding.

It is necessary to report the presence of guests at the facility, for which a rate of € 15 per day may be applied.

A "GUEST" is defined, regardless of the total occupants of the tent, who accompanies the customer occasionally to enjoy the services of the structure.

Each tent is furnished with two sun loungers, two deck chairs, a director's chair and a lockable container table. Please note that it is not allowed to use chairs and sun loungers from other locations.

All beach packages include entry to the pool, use of whirlpools, use of pedal boats and canoes, for which the presence of a lifeguard on the beach is essential.

For customers who use our beach towels, it is specified that upon arrival at the beach you will find a complete and sanitized towel set inside the table. It will be your responsibility to open them and withdraw them from the chairs at the end of the day. To request a towel change at a cost of € 20, simply inform the staff on the beach and leave the furnished tent.

We are happy to offer games for the little ones on the shore, two tents with sofas for the entertainment of children, a ping pong table in the covered parking area, in order to ensure peace and relaxation on the beach, at the bar and in the

pool.

In the bar and garden areas, drinks and food brought from home are not allowed. It is also forbidden to introduce refrigerated boxes and picnic equipment in the Bathing Establishment.

Car, motorbike and cycle parking is free and intended only for Bagno Grazia customers. The parking is not guarded, the Management is not responsible for any theft or damage to vehicles. It is allowed to park until exhaustion of places, without hindering the exit of other vehicles.

On the beach it is forbidden any activity that could disturb the peace and rest (ball, loud music, ...), as prescribed by the Ordinances.

On the beach it is forbidden to place any object on the roof of the tents and use the same as a drying rack.

At the end of the day, the inflatables (mats, dinghies and the like) must be stored in the appropriate area located in the parking lot.

The structure is happy to welcome dogs, for access to the shoreline and for a short stop in our gardens, with a leash and muzzle where required. Please note that it is permitted to stay in the tents on the beach with your dogs, only if they are small or very small, guaranteeing peace and safety.

The Management:

- not liable for objects and valuables in general, left unattended in the cabins, on the beach or in the common areas.

- reserves the right to cancel the booking of a tent, without any obligations whatsoever, in the event of non-compliance with the rules of this regulation, with consequent loss of the sums already paid by the customer.

- reserves the right not to accept reservations from customers who in the past have had incorrect or harmful behavior towards our seaside resort.

- makes available at its facility and on the website [www.bagnograzia.it](http://www.bagnograzia.it), information regarding the purpose and method of processing the common data provided for the correct administration of the contractual relationship between us (PRIVACY INFORMATION EUROPEAN REGULATION 2016/679 ), it also provides information on the processing of personal data of subjects during the COVID-19 emergency.
